# 1 Opening remarks and introductions

# 1.1 Introductory Remarks

Task Group chair Tom Palkert (Macom) convened regular meeting #149 of the INCITS/Fibre Channel Physical Variants Task Group on Thursday, 7 April 2022 at 9:00 AM (CDT). He introduced himself as chair and thanked Broadcom Inc for hosting the meetings and Marvell for hosting the virtual Zoom meetings. The chair next introduced Dean Wallace (Marvell) as the Task Group vice-chair and Jason Rusch (VIAVI Solutions) as the Task Group secretary.

- > Complaints about individual firms or other actions that might tend to hinder a competitor in any market.
