T11.3 FC-RDMA ad hoc work group regular meeting
4 Oct 2022 – 9:00AM-10:00AM EDT

The FC-RDMA ad hoc work group of the Fibre Channel Protocol (T11.3) Task Group held a regular meeting on 4 Oct 2022, hosted by SFF. Attendance was 11 people from 6 organizations and is tabulated at the end of this document.

1 Opening Remarks

Introductions

Chairperson Craig Carlson (Marvell) opened the regular meeting on 4 Oct 2022 at 09:05 AM CST and led a round of introductions and thanked the host (SFF) for providing the meeting facilities.

2 Meeting Policy

2.1 Attendance and Membership

The chair explained that attendance is recorded electronically at <https://standards.incits.org/apps/org/workgroup/t11>, and explained the procedure. Attendance at this meeting does not count toward attendance at the plenaries of T11 and its task groups (i.e., being here will not get you out or keep you out of membership jeopardy).

The chair stated that all persons present are considered members of this meeting and may vote on questions, limited to one vote per company present. He advised that although T11 does not limit participation in the activities of its work groups to representatives of T11 member organizations, it requires nonmembers to identify themselves as such. Nonmembers that expect they may participate in the activities of T11 regularly were encouraged to become members.

2.2 Code of Conduct

2.3 Patents

The chair indicated that among the rules and policies under which this working group operates are the ANSI intellectual property policies as specified in pages 1-3 of http://www.incits.org/pat_slides.pdf. He displayed these pages without comment or explanation, and directed that questions about the policy should be referred to the questioner's legal counsel or the ANSI General Counsel.

2.4 Antitrust

The chair indicated that among the rules and policies under which this working group operates are the INCITS Antitrust Guidelines. Any member of the meeting is responsible for objecting if he believes discussion in the meeting violates those guidelines. As examples, there should never be discussion of the following topics at any INCITS or INCITS subgroup meeting:

- Any company's prices or pricing policies;
- Specific R&D, sales and marketing plans;
- Any company's confidential product, product development or production strategies;
- Whether certain suppliers or customers will be served;
- Prices paid to input sources; or
- Complaints about individual firms or other actions that might tend to hinder a competitor in any market.

FC-RDMA Draft Standard Development T11/2022-00039-v004 Peterson (Broadcom)

David presented an update to his charts that outline the scope of work for the development of the standard.

Some design points discussed included

- Protocol Layer Diagram on slide 4 will be added to the spec. No objections.
- Functional model on slide 5 will be added to the spec. No objections.
- Using the terms Requestor and Responder were discussed... To avoid conflict with FC-FS-6 definition of Responder, qualify the terms with RDMA Requestor and RDMA Responder.
- Active/Active vs Active/Passive connections. Active/Active register as both Requester and Responder.
- RDMA Port registration and Discovery is the same as FCP, including SCR, GID_FF, PLOGI, PRLI (with 1st burst size)
- Communication Manager (CM) function (librdmacm). Dave showed some of the structures used in this realm. It was suggested that the WWPN could be used as the “sock_addr”. It is already defined as type 22 in IANA.
- GSI – implement in link services

The secretary lost internet for about 10 minutes at this point. Meeting had adjourned upon reconnect.
