The T11 letter ballot to forward FC-SP-2 AM2 for public review closed on September 19, 2022. The vote carried with 16 in favor, 0 opposed, 0 abstaining, and 3 not voting. The comment resolution process was completed during the October 2022 plenary meeting week and the results are contained in T11-2022-00288-v001.
