# Approved Minutes INCITS Fibre Channel (T11) Technical Committee Regular Meeting #179 05 October 2023 – 1 PM to 3 PM CDT Galveston, TX (Hybrid Meeting)

#### 1 Opening Remarks and Introductions

#### 1.1 Introductory Remarks

TC T11 chair Howard Johnson (Broadcom) convened regular meeting #179 of the INCITS Fibre Channel (T11) Technical Committee on Thursday, 05 October 2023 at 1:01 PM CDT. He introduced himself and thanked our host SNIA/SFF for the physical meeting facilities as well INCITS for the virtual meeting facilities.

He next introduced Patty Driever (IBM) as secretary. The Vice-Chair role is currently unfilled.

- Any company's prices or pricing policies;
- Specific R&D, sales and marketing plans;
- Any company's confidential product, product development or production strategies;
- Whether certain suppliers or customers will be served;
- Prices paid to input sources; or

 Complaints about individual firms or other actions that might tend to hinder a competitor in any market.

If such discussion is not immediately terminated, it is the chairperson's responsibility to terminate the meeting.

#### 1.3.4 Patent Policy Information

He displayed these pages without comment or explanation and directed that questions about the policy should be referred to the questioner's legal counsel or the ANSI General Counsel.

The Chair also pointed to the <u>INCITS Patent Registry</u> located on the INCITS website.

# 7.3 T11 Project Organization on ICMS (T11-2023-00007-v003) 7.3.1 Considerations

Distribution 'on' by default – Lynn is asking if we want to put the flag on by default that sends an email when we post a file. This is truly required for agendas, but not for everything else. And there's a real concern about getting a lot of extraneous emails. We agreed that committee chairs should focus on remembering to 'check the box' when posting agendas.

New project numbering scheme (example: INCITS 562-202x: (FC-FS-6) Information Technology – Fibre Channel.... It used to be that we put the 'FC-FS-6' tag first, but that caused problems for INCITS. So Lynn developed this new scheme that will allow us to find the project we're looking for in the pulldown, but it will also work for INCITS overall.

#### 7.4 Room Rates and Meeting Fee Evaluation

Chair indicated that he is still working with FCIA and hopes to bring in a proposal in December for how we might establish meeting fees and the logistics of doing so in order to ease the issues we have been having with contracting with hotels. He asked that we investigate with our companies if having a meeting fee will mean our companies would want that to mean we are not required to stay at the meeting hotel. However it was noted that the meeting fee will likely be greater for those who do not stay at company hotel.

#### 9.2.2 Letter to travel representatives on hotel rates (T11-2023-00011-v000)

The chair reminded the membership that

- T11 plenary meetings are hosted by volunteer organizations;
- A plenary host receives no reimbursement from T11 or INCITS for any expenses of hosting;
- A plenary host may depend on agreements with the meeting hotel in order to reduce the
  expenses of the host and also possibly, though not necessarily, reduced the room rates
  for the members; and
- A hotel may charge punitive extra fees to a host if the meeting does not achieve an agreed number of room nights identified with group members.

Therefore, T11 expects those attending meetings during a plenary week to stay at the meeting hotel and identify themselves as members of the T11 group, even though less expensive lodging may be found in the area, or even at the same hotel. Document T11-2023-00011-v000 has been posted which contains a letter to those with budget responsibilities for member organizations justifying this obligation.
